A RESOLUTION AMENDING THE
CITY OF MOUNTAIN VIEW MASTER FEE SCHEDULE
TO MODIFY THE CANNABIS BUSINESS REGISTRATION FEE

WHEREAS, On May 23, 2019, the City Council held a public hearing to consider amendments to the City's cannabis business regulations, which amendments require modifications to the City's Master Fee Schedule; and

WHEREAS, staff has reviewed and analyzed the cost of providing various City services and allocated overhead costs throughout the City departments; and

WHEREAS, the City seeks to achieve and maintain financial stability through reasonable cost recovery where appropriate to allow the City to continue to provide cost-effective services; and

WHEREAS, in connection with the development of cannabis business regulations, it is necessary for the City to adopt fees to ensure cost recovery for administration and enforcement costs; and

WHEREAS, the schedule of fees is reasonably related to the impacts and service needs created by cannabis businesses;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mountain View:

1. The following fees are hereby adopted as set forth in the schedules attached hereto and incorporated herein:

Exhibit A: Fee Schedule for Police Department as revised.

The effective date of this Resolution shall be July 25, 2019 to coincide with the effective date of the modified cannabis regulations.
